#### BAREBOAT REGISTRATION Issue of the Bareboat Certificate of Registry

A Bareboat registration under the flag of St. Vincent and the Grenadines may take place upon receipt of:

#### **Administrative requirements**

1. Application form filled in and signed
2. Minimum Safe Manning Application
3. Transcript or Register from the foreign registry
4. Certificate of Good Standing and Certificate of Incumbency of the Bareboat Charterers
5. Copy of the Bareboat Charter Party
6. Written consent from the foreign registry for the vessel to fly the flag of St. Vincent mentioning the bareboat charter period
7. Written consent from the mortgagees
8. Copy of the existing Tonnage Certificate
9. A.A.I.C./P.S.A. and confirmation from the Authority that they will be responsible for the radio traffic accounts
10. Certificate of Entry from the vessel's P & I (Third Party Liability, Cargo & Crew)
11. Payment of the relevant fees

#### **Technical requirements:**

##### **Class and Statutory**

- a. Classification Society to confirm that the vessel is in class and has valid statutory certificates. The Classification Society should also confirm that the vessel's class will be retained under the St. Vincent and the Grenadines flag and that new certificates will be issued after completion of the necessary surveys
- b. Confirmation from authorized organization that the interim SMC, ISSC and MLC / MLC Inspection Report are being issued (if ISM and ISPS Code and MLC are applicable)

##### **International Safety Management (ISM) Code (when applicable):**

- c. Copy of ISM Document of Compliance of vessel's operator and ISM Code Declaration of Company

##### **International Ship and Port Facility Security (ISPS) Code (when applicable):**

- d. LRIT Conformance Test Report (see Circ. SOL 030)
- e. All previously issued Continuous Synopsis Records
- f. Company Security Officer (CSO) and Designated Person Ashore (DPA) Declarations
- g. Application Form for Continuous Synopsis Record

##### **Maritime Labour Convention (MLC) (when applicable):**

- h. Application for the issue of DMLC Part I

FOR MASTER AND OFFICERS: APPLICATION FOR THE ISSUE OF THE STCW 78, (AS AMENDED) ENDORSEMENT IF THEY ARE NOT IN POSSESSION OF THESE DOCUMENTS.

FOR ALL SEAFARERS: APPLICATION FOR SEAMAN'S BOOK, IF THEY ARE NOT IN POSSESSION OF SAME.
