



ST. VINCENT AND THE GRENADINES

**AUTHORISATION FOR BAREBOAT REGISTRATION  
UNDER FOREIGN REGISTRY**

- I. The vessel must have permanent registration status under the Flag of St. Vincent and The Grenadines, i.e. the following must be submitted:
  1. Application Form filled in and signed;
  2. Original or certified true copy of the legalised and/or apostilled Bill of Sale;
  3. Recent Certificate of Good standing and Certificate of Incumbency of the owning company;
  4. Original or certified true copy of the Deletion Certificate from the previous registry;
  5. CSR Form 2 and all previous CSRs (if applicable) for vessels holding St. Vincent and The Grenadines registration certificates;
  6. Copy of International Tonnage Certificate, 1969 (if not already submitted).
  
- II Confirmation of registration and a Letter of Authorisation (Transcript of register) to register the vessel under a foreign Registry (bareboat registration) may be issued upon receipt of:
  1. Confirmation from the intended foreign Flag Authorities that bareboat registration is permitted;
  2. Written consent from the mortgagees (if applicable);
  3. Written undertaking by the Owners to surrender the Certificate of Registry within fifteen days from the entry into the bareboat charter registry;
  4. Written undertaking by the Charterers that the Saint Vincent and the Grenadines Flag shall not be hoisted during the period of bareboat charter registration;
  5. A copy of the bareboat charter party;
  6. Payment of the relevant fees. It should be noted that the Annual Tax(es) for the calendar year(s) is/are payable in advance for the whole bareboat charter period.
  
- III A Transcript evidencing the authorisation to sail under the foreign Registry for the whole bareboat charter period may be issued upon receipt of:
  1. Return of the original St. Vincent and The Grenadines registration certificates;
  2. Copy of the Foreign Bareboat Certificate of Registry evidencing record of the mortgage(s) (if applicable).
